USE OF SOCIAL NETWORK TECHNOLOGY

St. Clarence Youth Ministry utilizes a **Facebook group** to communicate information about our events to participating high schoolers. Membership in the Facebook group is limited to current high schoolers and is monitored by the staff and volunteers of St. Clarence Youth Ministry. St. Clarence Youth Ministry also posts general content to a **Facebook "fan page"** that is open to the public (www.facebook.com/stcym). Both adults and minors are able to view and post comments on the fan page. Comments on the fan page are also monitored by the staff and volunteers of St. Clarence Youth Ministry.

Photographs from Youth Ministry activities are posted on a **Flickr photostream** (<http://www.flickr.com/photos/stcym/>) but participants are not "tagged" or identified by name in these photos. Photos from Youth Ministry activities are sometimes also posted in the Facebook group, where only members of the group can view them. We do not post pictures of high schoolers on the public Facebook page.

St. Clarence Youth Ministry is not responsible for the content posted by high school Youth Ministry participants on their own social network accounts, including the "tagging" or identification of themselves or others in photographs. If inappropriate material is brought to our attention, we will do our best to address it with the appropriate parties, but individuals are ultimately responsible for the activity on their own accounts. **We strongly encourage parents to open their own Facebook accounts and monitor their teens' online activity.**
